The Company engaged the external auditors <u>or a firm or corporation affiliated to the auditors' firm</u> for the following non-audit works:

- Taxation matters involving amongst others consultation on land disposal, post tax incentives, tax assessment, special tax audit and country by country and transfer pricing reporting requirement.
- Continuation from year 2016 the Service Culture Consultation work for Customer Experience division, sourced via *due tender* process.
- Implementation assistance and maintenance support of TM Group Human Capital Management system for employee performance and compensation, sourced via due tender process. Total contract value is RM7.37 million for a period of 5 years, of which RM4.02 million represents software application license fee from a third party. For 2017, RM2.77 million of services were rendered, of which RM0.80 million is in respect of the recurring software application license fee from a third party.
